**TO: PLANHOLDERS**

The contract documents for the referenced project are clarified and amended as follows:

**DRAWINGS:**

Item No. 1: **Sheet E0.1, Specification Section 275100:** Contractor shall provide (2) additional assisted listening system transmitters for use with portable sound systems. Transmitters shall be configured for Wi-fi and FM broadcasting and turned over to the facility for storage. Additional antenna is not required, the antenna that comes as part of the transmitter shall be used.
