The specifications state that slatted fence price is to be based on square foot. The bid item is based on lineal foot. Please clarify if the bid item is to be based on sq/ft or LF. An 8′ tall fence would have 8 sq/ft of slats per LF and a 6′ tall fence would have 6 sq/ft per LF.

Response:

Will be based on Linear Feet (LF) and height of fence. (i.e., 200 LF of 6' tall chain link fence).

2. Question 2:

The specifications state that gate pricing is to be based on lineal foot of opening. The bid item is based on a per each basis. Please clarify if the bid item is to be based on LF or EA.
