RESPONSES TO BIDDERS' QUESTIONS:

1. <u>**Question:**</u> Per addendum #1 answer to question #1 it is stated that the slats pricing is to be based on LF of fence. This cost will vary between 4', 6', and 8' tall fence. It is not cost effective to provide one price for all heights of fence. We recommend making this bid item per SQ/FT. This will cover both MOA and the contractor so costs are correctly reflected for different heights of fence.

Response:

Fences listed as 4', 6', 8' will be priced with square foot (SQ/FT).
