RESPONSES TO BIDDERS' QUESTIONS:

1. Question:

Sheet S2, detail 2. Length of abutment says to see note 3. Notes below only has 1 and 2. Can you please share note 3.

Response:

Note 3: See 3/S3 for dimension.

2. Question:

Section C, Division 30 of the Special Provisions calls out the concrete for the bridge deck is to be Class A-A, but bid tab B-11 calls it out as Class A. Please clarify.

Response:

Bridge deck is to be Class A-A.

3. Question:

Do you want the abutments to be precast or cast in place? There is no definition as to what is preferred.

Response:

Contract documents detail cast in place construction.

4. Question:

We have been notified by a few of the bridge manufacturers that lead times are 12 months from date of order. Per the specifications the contractor has 90 days from NTP to complete the project. Will MOA extend the completion date for the alternate bid schedule to meet the bridge manufacturer lead times?

Response:

Yes, APR assumed the Add Alt would require suspension of contract construction calendar days during bridge procurement.

Where any requirements of the Invitation to Bid conflict with an item in an Addendum, the Addendum shall govern. All other terms and conditions of the Invitation to Bid shall remain unchanged and in full force and effect.
