QUESTIONS & ANSWERS

ITB #2023B006 Addendum #1, dated February 3, 2023

1. Question:

"It is my understanding that you only need my bid for our hourly shop rate. What I do not understand is how you determine the successful bidder when one company may quote 4 hours for any given component installation, and another may need 8 hours. I do not see a column for quoted hours per accessories. I understand that this would be a very difficult line item to describe, due to varying vehicles and optional accessories. But it is my understanding that you only need my hourly shop rate, and the time it takes to install the accessories will be determined at a late date?"

Answer:

Correct. We're only requesting your hourly rate for the purposes of evaluating bids. It's expected that the winning contractor will require a reasonable amount of time for accessory installation, as determined by the Contract Administrator.
