The contract documents for the referenced project are clarified and amended as follows:

**MODIFICATIONS/CLARIFICATIONS:**

Item No. 1: **REPLACE** in Section 3.1, Project Scope and Description, Paragraph 1 on page 6 of 14 of the RFP with the following revised Section 3.1, Project Scope and Description, Paragraph 1:

The main objectives of the W Bluff Drive/Ocean Dock Road Area Storm Drain Improvements project are to evaluate and characterize existing hydrocarbon contamination in the project area and evaluate design alternatives to rehabilitate the existing drainage system. Note that consultants currently under contract to provide environmental consultations or evaluations for Marathon Petroleum and/or Crowley Fuels are precluded from proposing due to conflict of interest.

Item No. 2: **REPLACE** in Section 3.2 Scope of Professional Services, Item 3 on page 7 of 14 of the RFP with the following revised Section 3.2 Scope of Professional Services, Item 3:

Perform an environmental analysis to characterize existing hydrocarbon contamination in the soil and groundwater surrounding the WBD/ODR storm drain system. **Qualified environmental professionals currently under contract to provide environmental consultations or evaluations for Marathon Petroleum, and/or Crowley Fuels are precluded from proposing due to conflict of interest.**

2. **Question:** Are firms precluded if they have active contracts for services that are not environmental but will be proposing to provide environmental services on this project?

**Response:** Yes

3. **Question:** Are firms precluded who provide environmental services as a subcontractor to a larger firm under an active contract with one of these organizations?

**Response:** Yes

4. **Question:** Can the Cyber/Privacy Liability insurance limit not less than \$3,000,000 requirement be reduced to \$1,000,000 or \$2,000,000?

**Response:** These are the current insurance limits set by the MOA. Because this is a RFP, the successful bidder may attempt to negotiate these limits during the negotiation stage. However, the final determination is made by MOA Risk Management.

**Where any requirements of the Invitation to Bid conflict with an item in an Addendum, the Addendum shall govern. All other terms and conditions of the Invitation to Bid shall remain unchanged and in full force and effect.**
